## **ENTRIES**

1. For the U19 Tetrathlon & Junior Open Tetrathlon competitions the maximum number allowed is 4 athletes per nation and gender. The host nation can compete with 6 athletes per gender - UIPM Competition Rules 1.12.8 (if free places)
2. For U17 the invitation is for unlimited number of the athletes and coaches per nation, but based on the received preliminary entries, the LOC, reserve the right to reduce the overall number of the athletes per NF.

## **EQUIPMENT**

Equipment control for fencing will be immediately before the first round and laser weapons checking will happen prior to the warm-up.

This cost will cover the expenses of your delegation for accommodation, meals and local transport (**Lisbon Airport**) from your arrival Friday dinner, 8th April until departure, 11th April Monday after breakfast.

Delegations are required to send by bank transfer 30% deposit of the total amount of your team accommodation invoice until **1<sup>st</sup> March 2022**, otherwise, the reservation will not be guaranteed.

Delegations arriving or departing before these dates and more than 2 different flights please contact with the LOC to confirm an additional cost to cover the local transportation.

NF wishing to arrange their own accommodation must pay an Accreditation Fee per participant (athletes, Coaches and officials) of 50 Euros per day (minimum 2

## **TRANSPORTATION PLAN**

## **ATHLETES´ LICENSES**

Athletes are only allowed to participate in UIPM sanctioned events if they are registered with the UIPM.

According the UIPM Rules all competitors must be current members of their Federation and are responsible for their own insurance cover for the event. The organizer will not accept any responsibility, financial or otherwise for loss, injury or illness of any delegation member.

## **COVID19 INFORMATION**

Information updated on the Covid-19 tests needed to enter Portugal and arrangements for participating in the competition will be provided later according to the most recent national health authorities requirements.

## **ENTRY FORMS**

We would appreciate the early confirmation of your intention to participate or not. Please submit Form A at the end of this document as soon as possible.

If you do not complete the information required or your delegation's deposit, we will assume that your delegation will not participate. Deadlines for the Entry Forms are as follows,

**Entry A & B: Entry forms must return before 1st March 2022**

**Final Entry C: RETURN BEFORE 29<sup>th</sup> March 2022**

Delegations are reminded of the Rule 1.14.3 & 1.14.5. Following confirmation of the final entries, a NF must enter the competition with at least one athlete. Any NF failing to take part after having sent their final entries will pay a fine of 600 Euros to UIPM.

If at your arrival, the team has less athletes and/or team officials than listed on the Final Entry Form and without informing the Organizing Nation/LOC at least 7 days prior to the arrival, the NF will pay a fine to the LOC of 200 Euros for each person not attending.
