Competition rules

The competition will be carried out according to the 2026 UIPM Modern Pentathlon Competition Rules and Equipment Regulations



Fencing:

- U19 - fencing ranking round

Obstacle discipline:



- indoor
- the obstacle course in accordance with the UIPM rules
- 70m obstacle track length
- number of obstacles: 8

Swimming:



- 50m indoor swimming pool
- 8 lanes

Laser Run:



- shooting range: 36+2 precision laser targets
- running course: outdoor
- handicap or handicap in groups

Financial

- Accreditation fee:

- The accreditation fee entitles participants to have lunch packets and water/refreshments during the competition
- Delegations must pay an accreditation fee for each participant (athlete, coach and official) to the LOC.
- The total amount due to accreditation fee has to be paid in cash at the desk on arrival, where it will be given an Invoice

- If on arrival for the competition, the team has fewer athletes and/or officials than listed on their Participation Registration and without informing the LOC at least 7 days prior to their arrival, the NF will pay a fine to the Organizing Nation/LOC of 200 Euros for each person not attending

Transport

LOC guarantees transportation from the national airport Zielona Góra – Babimost and Railway Station in Zielona Góra to the WOSiR Drzonków Resort and the return journey.

In special cases it is possible to transport the Delegation from the Berlin/Poznań/Wrocław airport on other days, after prior notification and agreement of the financial conditions with the Organizer (LOC). The LOC will also provide transport from the airport. The cost is 450€/bus(4-8 people)/round trip or 400€/car (maximum 3 people)/round trip. Driver will pick up the team up maximum to 2 hours after the plane arrivals
